

## What you need to know before you apply for debt cancellation

---

Before you complete the form, it is important to read this guide about:

- What applying for debt cancellation entails
- How to apply for debt cancellation.

You must use this form if you are applying for debt cancellation as a company, association, self-governing institution or foundation. If you are applying as a private individual or sole proprietorship, you must use form 51.005, which you can find at [gaeldst.dk/blanket51005](https://gaeldst.dk/blanket51005).

## What does applying for debt cancellation entail?

---

When you apply for debt cancellation, you are applying for cancellation or reduction of your debt to public authorities. This means that you are applying for cancellation of all or part of your debt.

Your debt can be cancelled on social or other special grounds. This also applies if your financial circumstances are unresolved.

Limited partnerships, general partnerships and shipping partnerships are not eligible for debt cancellation.

### Is a large part of your debt to private creditors?

If the company, association, self-governing institution or foundation has debt to other parties than public authorities, you can apply for a voluntary creditor arrangement with your creditors. A creditor arrangement is an agreement concerning how your debt will be repaid.

## How to apply for debt cancellation

---

- You must complete all relevant fields in the form.
- You must document all of the circumstances on which your application for debt cancellation is based.
- You must complete the form as a solemn declaration.

We can obtain more information if this is deemed necessary.

### How to submit your application

Download the form onto your computer before you start to complete it. Remember to save changes along the way, to make sure that your information is not lost.

#### *Online application*

You can send your application form with appendices to the Debt Collection Agency via [gaeldst.dk/kontakt](https://gaeldst.dk/kontakt).

If there are many appendices to your application, you may need to submit them in several batches. Your case officer will gather all of your appendices and application.

#### *Postal application*

You can also send the application form with appendices to the Debt Collection Agency, Postbox 49, DK-4930 Maribo.
